TERMS OF PARKING APPLY AT ALL TIMES

This land is private property and parking control is managed by UK Parking Control Ltd
Failure to comply with the following at any time will result in a £100 Parking Charge
(reduced to £60 if paid within 14 days) being issued to the vehicle's driver.



Disabled badge holders only in disabled bays. Valid disabled badge must be clearly displayed at all times.



All vehicles must be parked only within marked bays.



ANPR in operation.



3 hours maximum stay (no return within 2 hours).



Important: if you leave this site whilst this vehicle remains in the car park you may be liable to receive a parking charge.

DATA PROTECTION INFORMATION

Automatic Number Plate Recognition (ANPR) and Warden Patrol Services are in operation for the purposes of Car Park Management and enforcement, Data Reporting and analysing consumer behaviour and crime prevention.

For these purposes your personal data including vehicle registrations and your movements within the car park site may be processed by UK Parking Control Ltd to enable performance of the parking contract and/or to protect legitimate interests as follows:

- Provided to Police or security organisations in order to prevent or detect criminal offences.
- We may also share data about your vehicle with organisations that analyse consumer, driver and vehicle behaviour in this car park.

YOU HAVE THE RIGHT TO REQUEST US TO:

INFORM you how and why your information is processed, give you **ACCESS** to the information we hold, **RECTIFY** incorrect information about you that we hold; **DELETE** your information; **RESTRICT** our use of your information; **TRANSFER** a copy of your information to third parties and **OBJECT** to our processing of your information.

You have the right to **COMPLAIN** to the Information Commissioner's Office at www ICO.org.uk

We must verify your identity before carrying out your request. Where we disagree with your request, Data Protection law requires us to explain to you why we will not action it.

Unpaid Parking charges may be passed onto third parties such as debt recovery agents at which point an additional charge of £60 will apply.
